## Year 2000 Readiness Disclosure

*Touch N' Go® — The Desktop In-And-Out Board*

Due to the design requirement for *Touch N' Go* to run on 16 bit computers, the Microsoft Access® 2.0 database engine has been utilized, which, itself, is not fully year 2000 compliant. However, *Touch N' Go* does not utilize any of the non-compliant functions of Access 2.0. This has been tested and no year 2000 problems have ever been observed. Each user should, however, test *Touch N' Go* to determine that *Touch N' Go* does not have any year 2000 compliance problem in the user's specific operating environment.
